## Financials

- **\$45,901.95** in account
  - Approximately \$17,200 Rexburg invoices still pending to be paid in July
  - \$28,701.95 predicted balance at season end 6/30/26
    - Started the season 7/1/25 with \$28,303.21 making net gain close to \$0.
  - Recent Fundraising
    - Gala raised \$5,726.15
    - People's Choice Award raised \$1,402
    - Spring Show Sales tickets raised \$1,040

  - Sponsorship Designation Concern
    - Discussion around DBA's vs legal entity names
    - Reviewed process going forward for revision to programs or publications when it comes to business sponsors, suggested to have show committee review and approval in advance of publication.
    - Confirmed sponsorship forms clearly outline benefits and recognitions
- Voting Committee Updates
  - Lots of nominations covering a wide variety of the club
  - Based on acceptance responses we will be able to proceed without concerns for split votes
  - Discussed keeping a 9 member board with 4 officers and 5 board members
  - Proposed benefits of electronic voting and ballots through Google Forms
- Annual Meeting/Party
  - Annual Meeting will be June 6<sup>th</sup>, 9:30 AM at the Neutral Zone
  - Proposed separating annual meeting from annual club party to have an outside-the-rink get together
  - Discussed potential party locations such as Tautphaus park in late June early July for nice weather
- Membership and Ice Pricing
  - Reviewed proposed membership fees
    - Discussed increasing collegiate membership from \$155-\$170
    - Consider proposed ice prices and various membership plans
    - Review of Rexburg ice for the spring and summer to determine how much ice is being used
    - Hoping to get parent input at annual meeting
    - Discussed possible 'premium' membership for skaters who need the maximum possible ice time
    - Proposed show package in addition to regular ice times to include clinics and show practices as well as the actual show ice

- Freestyle Ice
    - Expressed concerns that many of the freestyle ice times that used to be available in Rexburg are being picked up by both hockey and Rexburg Learn to Skate
  - Learn to Skate (LTS) Idaho Falls
    - No updates. Heather still waiting to hear back from the City.
  - Fundraising
    - Encourage families to pursue fundraising outside of the fundraisers the club already participates in.
    - Club willing to promote and post about fundraisers when appropriate to support skaters efforts
