Financials

 - Outstanding March invoices from MAC and City still pending

Notes

- Open parent discussion at start of board meeting
 - Gala goal is still to sell 30 more tickets
 - Spring Show update- confusion around ice time and costs
 - Multiple skaters not present at show practice
 - Parent concerns should be discussed by entire board before being responded to
- Spring Show Ice Schedule
 - Brainstorm ways to cut cost of the spring show and accommodate confusion around show requirements
 - Reduce number of mandatory practices
 - lower cost of participating in show
- Learn to Skate (LTS)
 - Discussion regarding potential collaboration opportunities with the City of IF LTS program
 - Estimated annual program value discussed between approximately \$24,000-\$40,000
 - Interest expressed in exploring development of an Aspire program through the club
- Bylaws Review and Update
 - Discussion of updating Bylaws- One board member per household, no coaches as voting board members, adding verbiage around conflict of interests
 - Suggested to wait and allow upcoming board to make the changes
- Minimum Skating Skills to join club
 - Discussed advantages of having a basic skill threshold before someone joins club
- Annual Meeting
 - Discussion around annual meeting and end of year party
 - Suggested to have it during club ice in Rexburg in June
 - Nominations for upcoming board will be sent out before the annual meeting according to Bylaws
 - Create a nomination committee
- Clarification on comments made at last meeting
 - Amy has surveillance footage from meeting at Broulim's confirming that she was not acting in an aggressive manner and no chairs were thrown.

Decisions

- Prior Meeting minutes for March 18th and March 27th approved by all.
- Macee motions for \$65 show package that will include all mandatory show practices and the show itself, and will no longer require the Saturday morning mandatory practice before the show, Heather seconds. **PASSED majority vote**
- Staci motions that skaters must have passed Basic 2 and be at a minimum Basic 3 to be eligible to join the club, Heather seconds. **PASSED unanimously**
- Heather motions for the annual meeting to be held June 13th in Rexburg during club time. If girls skate, they need to pay for ice that day, Kayla seconds. **PASSED unanimously**
- **Heather** motions for nomination committee to consist of Macee, Kayla, and Staci and that all three must be included on any nominations emails, Staci seconds. **PASSED unanimously**
